a) OLD FOOTBALL PAVILION, PLAYING FIELDS - SOUTHBOROUGH F.C.

Council Members **NOTED** that the detailed programme of works must then come back to committee for agreement before a formal discussion with the contractor responsible for the Facilities Management Contract can take place.
