Hi Carolyn,

Many thanks for your response. Diana has asked me to reply on the society's behalf.

It's great to hear that other residents have taken an interest in the natural history of the cemetery and that KHWP are going to undertake a floral survey. Would you be able to share the details of who at KHWP is leading this survey as we would be keen get in touch to partner with them?

We completely agree that it is crucial to maintain the peace and tranquillity of the site and not to damage the memorials. I have led several natural history events before in cemeteries on behalf of the London Natural History Society and London Wildlife Trust, such as at Nunhead Cemetery, Tower Hamlets Cemetery, and Tottenham Cemetery among others, and am familiar with the issues that attend these types of sites and the behaviours required. I am also a friend of Woodbury Park Cemetery and have undertaken a floral survey of that site in the past.

The events we had in mind were possibly one heritage walk in the late summer and one fungi walk in the late autumn. Both would involve relatively small numbers, maybe c.10-15 adults, and we would keep to the paths. We would be happy to consider any other reasonable measures you thought appropriate.

The suggested surveys would involve c.2-3 people and would be no more than walking around the site for an hour or two. The suggested insect and moth surveys would involve leaving traps out overnight on c.5-6 nights between May and September. The reason for asking for out of hours access is so that these could be placed at dusk and retrieved at dawn. Fungi surveys involve no special equipment in the field and is simply about walking, observing, taking photos, and taking a few specimens to study under the microscope. Bat surveys involve walking around with bat detectors and heat cameras, again at dusk or early evening in the summer months.

As part of any publicity and articles we would be happy to include all the points you raise about respecting the special status of the site.

I would be happy to provide more details on our proposal if that would be useful to you. I would be equally happy to meet and talk though these points in person if that is easier.

About the Southborough Society

The Southborough Society ('the society') is the civic and heritage society of Southborough and High Brooms ('the town'). The society exists to stimulate interest in and care for the environment and character of the town, its history and its surrounding countryside. The society is a registered charity with approximately 400 members and is open to everyone.

Southborough Cemetery

As well as providing a place for burials and remembrance, Southborough Cemetery ('the cemetery') is an important heritage asset of the town, an open space rich in history, architecture, and wildlife.

Local natural history experts have long recognised the cemetery's potential for nature and over the years several intriguing records of potential conservation importance have been made, such as the presence of rare orchids and waxcap mushrooms.

These finds are likely to be indicators of semi-natural, unimproved grasslands, a habitat seriously threatened throughout the UK and Europe according to Natural England.

Proposal

The society asks permission from the town to undertake a programme of activities focussed on the heritage and natural history of the cemetery in 2024 and 2025.

The purpose of the programme is:

- 1. to stimulate interest in the cemetery amongst the residents of the town, and
- 2. to improve understanding of the ecology of the cemetery and surrounding landscape.

Such activities may include:

- volunteer-led surveys of the cemetery: wildflowers, mushrooms, bats, birds, moths, and other pollinating insects;
- public walks and talks;
- public displays;
- articles and papers in local and nature journals; and
- press releases and social media articles.

As a secondary purpose, the outcomes of the survey work could be of assistance to the Southborough Town Council when considering the cemetery's management plan, as we believe that changes to the environmental management of the older, inactive parts of the cemetery could be beneficial to promoting wildlife, such as not mowing the grass during spring and early summer.

The programme would not incur any monetary costs for the Town Council, nor involve any activities that would present any obvious health and safety risks.

The survey work is likely to require access to the cemetery on a few occasions when it is normally closed to public access. We would look to liaise with STC on the details of any such arrangements, including avoiding any clashes with burial and site management activity.

The survey work may include the removal of a small number of specimens for detailed examination so that they can be identified to species level. This will not have any impact on the site's ecology.

The results of any surveys would be recorded with the relevant biological recording organisations covering West Kent for public record and would be shared with the Town Council. We would be happy to provide a formal report at the end of the programme to the Town if that would be useful.
